Our December guest speaker is a charter member and former President of the Bull Run Civil War Round Table - Gary Ecelbarger. He has authored several articles and reviews for Civil War and historical magazines, and has been a consultant and contributing writer for two volumes of Time-Life Books Voices of the Civil War series. His first book, "We are in for it!: The First Battle of Kernstown, was the editor's Civil War selection of the History Book Club in November of 1997. Ecelbarger's newest book, Frederick W. Lander: The Great Natural American Soldier, was nominated by LSU Press for the 2001 Lincoln Prize, awarded annually for the finest scholarly work on the era of the American Civil War.

Frederick Lander was dubbed "The Great Natural American Soldier" by Brevet Lt. Gen. Winfield Scott, yet no markers or monuments exist to honor him. He ranked

among the most popular Americans in 1861, yet few today have ever heard of him. His name evoked passion from friends, peers, and subordinates, yet he rarely appears in any Civil War publication. He was the general of record who opposed and continuously foiled General Thomas J. Jackson for two months, yet most would have to think long and hard to identify the campaign. Forty thousand people — including Abraham Lincoln — attended one of three funerals to pay their last respects to him, yet today he essentially lies in an unmarked grave.

Gary's book will not be available at the 14 December meeting. He will have a copy of the Galley proof and will be taking orders. The book will be discounted 20% for Round Table members. If you would like to have your copy mailed prior to Christmas a 3.00 postage fee will be added bringing the grand total to 35.00. Copies will be available at the January meeting for 32.00.

GOOD NEWS! DAVIS TRACT ON THE SECOND MANASSAS BATTLEFIELD SAVED

I attended the news conference at 10:00AM, 28 November at the MNBP Visitor's Center where 51 interested individuals listened to some very welcome words from President O. James Lighthizer of the Civil War Preservation Trust (CWPT). He formally announced that the CWPT had purchased the 136 acre "Davis Tract" from the estate of Edward P. Davis on 14 November for the amount of \$600,000. (See the accompanying map.) Another \$30,000 was expended to cover court costs and attorney fees.

While the Davis Tract lies beyond the <u>authorized</u> boundary of the MNBP, there is no question that it was part of the Second Manassas Battlefield. Well-known historian, John Hennessy, also spoke to the assembled gathering. His professional assessment of the importance of the Davis Tract was key to the acquisition drive. At the conference Mr. Hennessy stated that the cited terrain was "the most important and one of the most bloodstained lands that lies outside the park's boundary."

The drive to acquire the Davis Tract would not have succeeded had it not been for the members of the preservationist minded, Sudley Mountain-Stony Ridge Civic Association (SM/SRCA). These individuals represent about 30 households in the vicinity of the Davis Tract. To date (29 November) the SM/SRCA has raised slightly over \$80,000, with outstanding pledges for \$20,000 more. Their fundraising

goal is \$130,000. In recognition of the accomplishments of the SM/SRCA CWPT President Lighthizer stated that he could not remember any other example where a local civic association came up with serious money in partnership with a national preservation organization to preserve historic land.

Mr. Greg Gorham, a property owner north of the MNBP deserves credit for providing the impetus to acquire the tract. Back in late 1998, he observed a "For Sale" sign on the property and subsequently obtained a contract for the 136 acres. Other individuals deserving recognition include President Jack Hermansen of the SM/SRCA and none other than BRCWRT member Claude "Brad" Bradshaw. He is the Fundraiser Chairman for the SM/SRCA

President Jack Hermansen also advised me, via letter, the assistance provided by the Save the Battlefield Coalition (SBC) is specifically due to:


Betty Rankin - President, SBC

Annie Snyder – Chairman, SBC. Annie, a life member of the BRCWRT. led the successful efforts to acquire the William Center Tract (541 acres) for the MNBP (1988) and Keep Disney out of Haymarket (1995)

While the CWPT has title to the land, it still has to raise money to pay the \$600,000 cost for the acquisition. To date the SM/SRCA donated \$80,000 and a matching grant from the Federal Government added another \$200,000. The amount of other donations is unknown.

UPDATE ON THE MANASSAS NATIONAL BATTLEFIELD PARK

If you have not been out to the MNBP recently, the following "Bullets' may be of interest to you. Information is current as of 28 November 2000:

- New parking lot on the north side of Matthews Hill and east of Route 234 is in use. It is well sited. It replaces the parking lot described below.
- Old parking lot and picnic area on Dugan Ridge and west of Route 234 has been closed permanently.
- Construction has <u>not</u> begun in the vicinity of the Stone House Intersection (U.S. 29 & Route 234).
- Road running northeast/southwest along Chinn Ridge is closed to motorized traffic. Road block is near Chinn House site.
- Old parking lot north of U.S. 29 in Prince William County and just west

of the Stone Bridge over Bull Run has been removed and the area relandscaped. It has been replaced by one described below.

 New parking lot in the vicinity of the Stone Bridge is on the Fairfax County side of Bull Run and is on the north side of U.S. 29. It is in use and is better located than the old one.

PRESERVATION 2000

Preservation 2000, an event held near Upperville, Virginia, came off as scheduled on 29 October 2000. It was a real gem for those who attended. Representatives of several major Civil War preservation organizations were present and set up shop to sell calendars, video tapes, books and Tshirts. A modest-sized group of reenactors (about 3 companies per side) put on a first class set of demonstrations and recreated the skirmish of November 2, 1862 just south of Snicker's Gap. The reenactment was held just to the north of the Ayrshire Farm. The demonstrations of battalion infantry tactics and artillery firing were great! The weather was bright and sunny, but breezy and cool: Still it was a beautiful fall day!

Speakers included Bud Hall (Brandy Station Trust), Brian Pohanka, and Ed Bearss. Several other speakers talked about civilian life during the war, the actual appearance of the Confederate soldier in the

field, and several other topics which I missed.

For the first time to my knowledge, Ed Bearss abandoned his trademark uniform of T-shirt and ball cap with swagger stick, and maybe a shell jacket, to participate in the uniform of a Confederate captain, 35th North Carolina Infantry. (I have, on rare "formal" occasions, seen Ed don a coat and tie, but never a Union or Confederate uniform!) Ed spent the night before the event with the 35th NC reenactors in the field and accompanied them on their 10 mile march to the site. He had his blanket, roll, canteen and haversack on for the entire event. BRCWRT members will be interested to know that Ed will be our guest speaker in May 2001.

Money raised from Preservation 2000 will be divided between several preservation organizations in Loudon County, other parts of Virginia and even in the West (Shiloh was mentioned and there may be others).

American Soldiers Then and Now

After the capture of Brownsville, Texas, General Nathaniel Banks, USA, paid an official visit to the American Consul in Matamoros. The Mexicans, having previously learned of his intention to do so, decided to give him a public reception. A deputation was dispatched to invite him to the Public Hall. The military were paraded, a salute was fired, and all the enthusiasm of a gala day was manifested. Speeches were made by Seniors. Argues, Cartina, and others, expressing their sympathy with

Federal cause in the United the States, and their belief that the result would be favorable to the cause represented by General Banks. General replied, Banks hoping that Mexico would come out of her present troubles triumphant, and, after a great many mutual expressions of friendship and sympathy, the party adjourned to the office of the American Consul. citizens of Matamoros were highly pleased with the quiet, unassuming manner of the American General. One poor fellow, however, seemed greatly disappointed. He was an old Mexican soldier, had fought at Palo Alto and Resaca de la Palma. He evidently expected to see something more than human.

"Ah, Senor," said he, "the Americans are not what they were at Palo Alto. I remember them well there: their horses were larger than elephants, and the head of a mounted American reached the heavens!"

On May 27, 1861 Peyton Anderson of the Rappahanock Cavalry, while serving Pickett duty on the Falls Church Road in Fairfax County, became the first Confederate soldier to shed his blood for the cause. In the same incident, his comrade William J. Lillard was the first Confederate captured during the Civil War.
