EDWIN C. BEARSS PRESENTS THE SIEGE OF VICKSBURG

Edwin Cole Bearss grew up on a Billings Montana Ranch near the Custer Battlefield. His intrest in the Civil War started young; as a boy, he named the cattle on the farm for generals and battles (his favorite milk cow was "Antietam").

Mr. Bearss attended St. Johns military Academy and served with the 3rd Marine Raider Battalion and 1st Marine Division in the invasion of Guadalcanal and New Britain during WW II. He was badly wounded by machine gun fire and spent 26 months in various hospitals. Mr. Bearss recovered, received a B.S. from Georgetown, and later earned an M.A. in history from Indiana University after writing a thesis on Pat Cleburne.

Ed's National Park Service career began in 1955 as a park historian at Vicksburg, Mississippi. He was chosen Man of the Year at Vicksburg in 1963. His three-volume, 2200-page chronicle, *The Vicksburg Campaign*, is the definitive work concerning the siege. He has since published several books and articles, done detailed studies for the National Park Service for many park sites, and was featured as a commentator in the 1990 PBS series, "The Civil War." His contributions have earned him several awards of achievement, including the Department of Interior's Distinguished Service Award, Fellow of the Company of Military Historians, and the Harry S. Truman Award for Meritorious Service in the Field of Civil War History.

Mr. Bearss has 44 years of Government service under his belt, and currently presides as the chief historian of the National Park Service. His Smithsonian Tours are always sold out, and his speeches and lectures are usually standing room only. His lecture at BRCWRT last May on Grant vs Lee in 1864 was the largest attended meeting in this organization's history. We expect similar numbers, if not more, this year. So come early to get a good seat, and bring a friend.

There is still time to join the Bull Run Civil War Round Table's third self-guided tour on Saturday May 14, 1994 (the Saturday after the Ed Bearss meeting). Our destination this campaign will be a portion of the Western Maryland Campaign of 1862. We will start from the picnic area of Manassas Battlefield at Dogan's Ridge (approximately one-half mile north of the Stone House intersection on the left hand side of route 234) at 7:30 am. The group will, by caravan, head north to White's Ferry, then to Antietam Creek to review the action that occurred during Robert E. Lee's First Northern Invasion. As has been the case with the other tours of 2nd Manassas and Gettysburg, this tour will be member guided; i.e., Round Table volunteers will be "tour guides" at each of the eight selected stops on this campaign:

PRESERVATION UPDATE

Manassas Battlefield

The National Park Service proposes to relocate high-voltage power lines that currently spans the Stuart Tract. The preferred new route is around the perimeter of the tract along Pageland Lane. On March 23, the Park hosted a public information meeting attended by BRCWRT member Joe Gray. Costs to relocate the powerline will be \$3-4 million. Underground burial of the power is apparently not possible because of the high voltage of the line. This action will remove the powerline as a direct intrusion on this important partof the battlefield, but will not hide it completely.

Chantilly Update

After voting in January to acquire Parcel 5 for addition to the existing Ox Hill (Chantilly) Battlefield Park near Fair Oaks Mall, Fairfax County has approached the landowner who has agreed to sell. However, another party currently holds a prior option to buy the Parcel and negotiations continue with that party on appropriate compensation.

Bristoe Station

On Tuesday evening, May 3, the Prince William County Board of Supervisors will have considered a Comprehensive Plan amendment that will direct future land use at Bristow, VA, (formerly Bristoe Station) site of battle action in 1862 and 1864. The results of this meeting will be presented at the May 12 Round Table meeting. The recommendation of the County Planning Commission provides for low density residential uses over key portions of the battlefield. The BRCWRT has supported this alternative because it prevents high density residential uses, but we realize that even this alternative does not provide for direct set-asides of land for battlefield preservation. We will continue to work with the County in search of such an alternative.

Kernstown/Pritchard's Hill Update

In April the Frederick County Board of Supervisors and the City of Winchester's Common Council allocated \$500,000 to the F&M Bank in Winchester to prevent the sale of the Charles Hardy Grim estate via public auction. This joint action by the city and county holds the property for two more years until enough money is raised to completely purchase it. The 375-acre estate includes Pritchard's Hill and other lands that were an integral component of the 1st Battle of Kernstown fought in 1862 and the 2nd Battle of Kernstown fought in 1864. In January the Bull Run Civil War Round Table sent letters of support to city and county board members as well as to Congressman Wolf and Governor Allen urging their support for the purchase of this battlefield property. We will continue to work with these parties until the land is successfully purchased.

FROM THE RANKS

The Battle of Fair Oaks/Seven Pines began on the last day of May and ended on June 1, 1862 at the gates of Richmond. The following two unpublished accounts depict different views of the battle, as seen by Biily Yank and Johnny Reb.

From James Miller - 105th PA, Co. K. - Kearney's Division

Just as we halted at the woods, before entering the slashing, one of our men, who was more dependent on the Government than the Government was upon him, stepped out of the ranks. Captain Thompson ordered him back, but he made some excuse and was forgotten for the moment, and the regiment was ordered forward; but Captain Thompson, seeing the man was gone, in his firm manner said: "Serg't Miller, hunt him up and bring him back." I searched for him but he was too old a coon for me and had made good his escape. I then started to rejoin my company, but the regiment was out of sight; and owing to the thick woods I passed it, and found myself on the left of the 63rd PA. I was about to pass toward the right to again look for my regiment, though the men were all in a kneeling position, and a man who would rise to his feet ran the risk of drawing a direct fire. At this moment an officer of the 63rd requested me to go some 15 rods to the left in the woods and act as an outpost. I told him I would have to report to my own regiment but he told me I could not cross that fire. I then took my position according to my orders, but we were soon flanked on the right and I soon found myself inside the enemy lines.

I got in with another soldier of another regiment, who had been served in the same manner, and we passed over the field where the fight had been. Some of the wounded rebels glared defiantly at us, but we were armed and uninjured, and they could not molest us, even had they been able. We went into the edge of a woods and slept soundly until morning. About sunrise we rose and began to consider how we would get out of the dilemna we had so easily gotten into. Observing some works a short distance from us my comrade said he was going to see what they were, and though I tried to dissuade him, he started toward them but had not gone far until he received a volley from the rebels there which brought him back to me in a hurry. We then started and made our way around their right, reaching ourlines about 11 a.m. that morning.

From John W. Huddleston, of S.D. Lee's Artillery, to his brother - June 1, 1862 Letter in possession of the VA Historical Society

At 8 o-clock the "old bugle sounded the welcome and familiar sound "forward" and we formed in line of battle in an old field a half mile from our camp. At 9 o-clock A.M. the yankees advanced 12,000 infantry and 3000 cavalry on our little force of 1600 where a hot and fearful and bloody fight ensued, forcing our men back under shelter of our guns - the battle now opened in all its terrible grandeur - our fireing was at the rate of 4 rounds to the minute or 240 to the hour. Our General reports that every shot fell in their midst, killing great numbers. This continued for two hours when our ammunition gave out, and we run our guns back to camp for fresh supplies.

The enemy took advantage of this cessation in our artillery fireing and pressed our little band of 16,000 until they were entirely surrounded. Beside the Yankees had run up a battery to within 600 yards of our position supported by 1000 infantry and 700 cavalry (fresh troops). We again rushed up to our old position and found our men

bravely standing their ground against such tremendous odds of at least 8 times their numbers, and after a fierce and terrific struggle with the aid of our guns plowing roads through the ranks of the enemy, they bravely cut their way out. We had on the field of the 3rd Va. Cavalry 104 men who acted very unbecomeing to our cause. 700cavalry charged our Battery and the 104 men instead of supporting us as they should of done, fled from the battlefield in great confusion. But the 7th Tennessee came to our assistance, and I cannot describe how nobly they stoodtheir ground - on come the 700, and by the time they got to within 60 yards of us, every fire from our Battery, no less than 100 were swept from their horses....

Let us, my dear brother, thank God for his kindness in shielding and bringing me safely through this fearful conflict, for I feel that He alone has sustained and shielded me in our conflict. At Yorktown and Williamsburg I was bathed and baptised in human blood, was brushed and bruised many times by horrible missles of death and destruction, but than God I have not faltered nor shrunk from my post or... to my country my people or my God and I trust that I may not until the fanatic foe is driven from Va. soil and liberty echoes from every hill and Valley of our Southern Country.
